

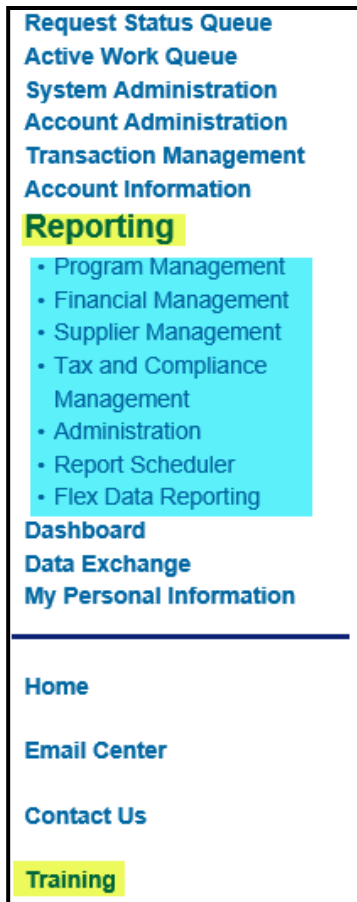

# USBank Access Online Standard Reports

USBank AccessOnline offers several different types of reports that the State of Alaska (SOA) utilizes. This document gives you summary of the standard reports available, provides reasons on why you may choose to use the report and provides the relevant fields on the report.

In addition to this document, you may also find the Reporting [Training](#) site on AccessOnline useful as this site offers additional user guides and report samples.

Keep in mind the results shown on the output of each report are based on the security of user who is running the report. For example, if the user running the report has access to all of their Departments CTS and Managing Accounts, the report(s) will show information for all accounts. However if the user running the report has access to one specific CTS or Managing Account, the results of the report will only show information for that specific CTS or Managing Account.
