STATE ADMINISTRATIVE MANUAL—TRANSMITTAL NUMBER 49

The following sections within the Alaska Administrative Manual are being revised with this transmittal letter effective January 1, 2006.

Expenditures

- AAM 35 Several expenditure sections have been relocated within Section 38 Payment Methods. In addition, the removal of these sections made it necessary to renumber Section 35. See the attached spreadsheets for cross-references of Sections 35 to 38, plus the renumbered Section 35.
- AAM 35.010 Expenditures. Policy requiring payments direct to vendors is added.
- AAM 35.200 Tax Liabilities on Vendor Transactions. This section is revised to reflect current practices regarding taxes.

Payment Methods

AAM 38 Payment Methods is a new section. This section incorporates several sections previously within section 35 as well as new provisions. Section 38 was added to clearly identify the methods the state uses to make payments. Compliance with laws and new technology over the last few years resulted in many changes in this area.

Travel/Moving

- 60.210 Completion of the Automated Travel Expense Report. This section is modified to include a statement that if final travel reimbursements are less than \$.50 they will not be paid, and reimbursements of \$.50 to \$.99 will be rounded to \$1.00 and paid by the State to the traveler. This will avoid the issuance of general warrants to employees of less than \$1.00.
- 60.250 Meals and Incidental Expense (M&IE) Allowances. Statement was added that M&IE rates are reviewed annually and adjusted as appropriate.

• AAM 60.325, 60.350 and 60.360 – These three sections are updated to reflect the reduction in the IRS standard mileage rate for 2006. The standard mileage rate for business miles driven is dropping to 44.5 cents per mile, and the nontaxable moving mileage rate is now 18 cents per mile. This is a change from the October 2005 rates of 48.5 cents and 22 cents respectively. The applicable forms will be updated with the effective date of January 1, 2006.

Payroll - Settlement Pay and Arbitration Awards

AAM 310.170 – Public Employee Retirement System. This revision is a clarification of PERS contribution on offset wages related to a settlement and arbitration.
