This report is only available in an electronic (PDF) format at the Division of Finance's website. The electronic report will be available by January 31, 2021. This report is not published in a hardcopy format.

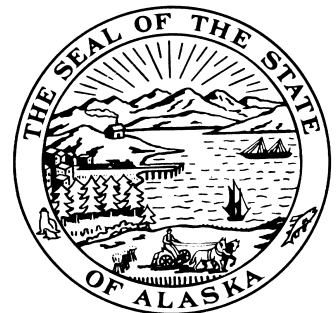
