LearnAlaska Tips and Tricks: Browser Settings

The use of LearnAlaska requires that some browser settings be updated in order to avoid potential issues. Most important is that you use Microsoft's Internet Explorer with your pop-up blocker disabled and Compatibility View enabled to access LearnAlaska.

A reference document titled Recommended Browser Settings was created to help you configure your browser settings and can be found on the LearnAlaska Portal page at <http://doa.alaska.gov/dof/learnalaska/resource/Browser-Setup.pdf>. Many of the issues that users contact the LearnAlaska Help Desk for assistance with can be resolved simply by updating browser settings. Here are a few issues that you might notice and which browser setting might fix them.

I click on the "Request Access" or "Enroll" button and nothing happens

This issue occurs most often when the pop-up blocker is turned on. If you turn off pop-up blocker you should have the following interaction to either "Request Access" or "Enroll" in a course.

When you click on "Request Access" or "Enroll" in LearnAlaska a window opens up over the screen that has the person select their appointment data before submitting the request to the

system. Once the information from the window is submitted then the page reloads and the information changes based on the interaction submitted ("Request Access" or "Enroll").

I click on "Approve" and nothing happens

The specific issue happening depends on which approve button you are clicking. If you are clicking the button that appears at the bottom of the Approval Console after you have searched for the approval request than it is an issue with the pop-up blocker being turned on and you will need to check your browser settings and turn pop-up blocker off.

When you are processing an approval request a pop-up window appears that asks for your reason of approval or denial and asks that you select the appointment information of the user requesting approval. If this window does not appear than the approval will not be processed.

On the other hand if you get the window to appear, but when you click the button to submit it seems to just be taking a long time this can occur when the system is just taking a while to process and it is recommended you just give it a little extra time to process.

I go to the course, but there is no information on the screen or I am not seeing anything listed in the Course Catalog

This issue usually occurs when you are using Internet Explorer 10 or higher but can happen in Internet Explorer 8 or 9 if you have not enabled Compatibility View. Please review the Recommended Browser Settings document for instructions on how to enable Compatibility View. Once you have completed those steps you

should be able to refresh your browser page and navigate in LearnAlaska with better results.

The course details screen is not aligned correctly

Users of Internet Explorer 11 have found that the information panel is actually getting placed to the far right off the screen and if they scroll they can find the information. We have found that the solution is to add the LearnAlaska URL to your list of Intranet websites. Detailed instructions can be found in the Recommended Browser Settings

document referenced above.

Updated Performance Evaluation Form Features

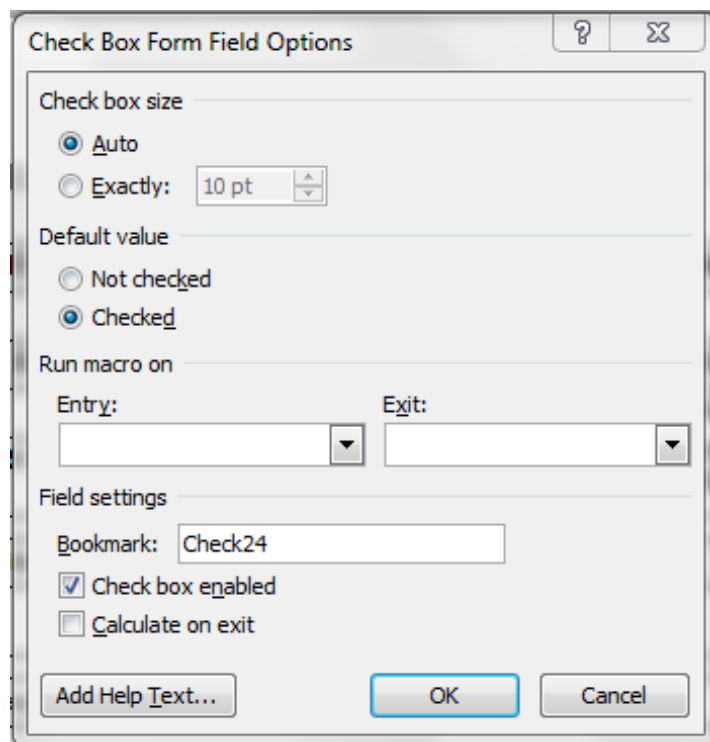
The Division of Personnel and Labor Relations has been receiving feedback on the limited features available in the Performance Evaluation form. In an effort to create a more user friendly experience, we have done some research and were able to add the following features to the locked form:

- Spell Check
- Format Text
- Add Comments

We recognize many users desired to have Track Changes available, but due to the way Microsoft Word allows forms to be locked, this is not possible at this time. Another change resulting from the new form is checkboxes will no longer be clickable objects. Instead, a user will need to double click on the checkbox. In the pop up box that opens up, select "Checked" for the "Default value" (see example right).

2015 OSHA Reporting Requirements Update

Starting January 1, 2015 reporting requirements for Occupational Safety and Health Administration (OSHA) were updated. This change requires fatalities to be reported within 8 hours, a current requirement for the State, and that all work related-inpatient hospitalizations, all amputations, and all losses of an eye must be reported within 24 hours. These types of injuries can be reported by calling the numbers below AND by filling out a report of injury form:

- 1-800-770-4940 or (907)269-4940 (8 am to 5 pm M-F; AK time)
- 1-800-321-6742 (After 5 pm or on weekends and holiday)

Best practice when reporting any

type of injury or illness is to report it immediately. For more information about reporting injuries you can visit the Department of Administration, Division of Risk Management website (<http://doa.alaska.gov/drm/>) where you can access both the employee reporting form and the employer reporting form (management) as both are typically required. The claims manual on the Risk Management website is also a great reference for additional information.

The 2014 W-2s were sent to the mailroom for distribution to State of Alaska employees on Tuesday, January 20, 2015. Requests for duplicate 2014 W-2 forms began to be processed on February 2.

Requests for 2014 W-2 reprints should be directed to the Employee Call Center by email at employeecallcenter@alaska.gov, by phone at 465-3009, or by fax at 465-6624. Every effort will be made to process duplicate 2014 W-2 requests within one business day between February 2 and April 15, 2015.

Employees of the Office of the Governor, Legislative Branch, and the Alaska Court System should direct requests to their Human Resource Office; all other employees should contact the Employee Call Center.
