**F.O.B. Point:** The F.O.B. point for all orders is Seattle, WA. All prices include shipping to these locations. All shipping and delivery costs from Seattle to the final destination must be a pass-through charge. The contractor must pre-pay these costs and charge back those actual costs to the ordering agency.

All emergency or rush deliveries that require special shipping and delivery will also be at the ordering agency's expense as a pass-through charge. These types of deliveries must be approved by an ordering agency prior to shipment. All shipping and delivery costs shall be added to an invoice as a separate line item.

**Prompt Payment Discount:** For deliveries in the Anchorage, Fairbanks, and Juneau areas, Mohawk Resources offers an additional 5% discount, and VSG offers a .5% discount, for all invoices paid within 10 business days from the date of receipt of the commodities or services and/or a correct invoice, whichever is later.

The Anchorage, Fairbanks, and Juneau areas are defined as within respective city/borough limits and all surrounding communities that are accessible by roadway and within a 50-mile radius of city/borough limits. For deliveries outside these areas, the discount shall apply for invoices paid within 10 days of the date of shipment from Seattle, WA.

The discount shall be taken on the full invoice amount. Payment being made is considered either the date a printed warrant is issued or the date an electronic funds transfer (EFT) is initiated.
