### **Specifications**

- Sizing, measurements, and final fitting are done at no expense
- Improperly fitted armor must be adjusted or replaced at no expense within 30 days of Purchasing Entity acceptance of product

### **Documentation**

- All orders must include the following:
- Name of Purchasing Entity
- Purchasing Entity contact information
- Order date
- Product description
- CPL model number and threat level (if applicable)
- Serial number
- Price
- Master Agreement number and PO number

### **Shipping and Delivery**

- All orders must be delivered to the Purchasing Entity within 60 days of Manufacturer receipt of order
- Contractor can direct ship to the Purchasing Entity or ship product to the distributor
- All shipping charges and associated costs are the responsibility of the Contractor
- Purchasing Entity will not be responsible for any additional charges, should Contractor fail to observe specific delivery days and receiving hours
- Packages that cannot be clearly identified may be refused and/or returned at no cost to the Purchasing Entity

### **Warranty**

- 5-year Manufacturer warranty on ballistic panels
- 18-month Manufacturer warranty on Carriers
- Warranty period begins upon acceptance by the Purchasing Entity
  - **NOT** when Distributor receives product
