NOTICE OF HEARING AND PROCEDURAL ORDER

A hearing in this case will take place before the Alaska Public Offices Commission at approximately 12:00 p.m. on Thursday, January 16, 2025.

The Commissioners will be present in-person, by telephone, or via Microsoft Teams and will receive evidence regarding this matter. You may be present at the hearing either by telephone (1-907-202-7104, Access Code: 542 592 595#), in-person (2221 E. Northern Lights Blvd, Ste 128, Anchorage, Alaska, 99508), or via [Microsoft Teams Meeting](#).¹ You may be, but are not required to be, represented by an attorney or agent.

If you wish to participate by telephone and are an individual who requires a special accommodation to participate, you must advise the Commission office on or before January 6, 2025, so that a special accommodation can be made.

PREHEARING AND HEARING PROCEDURES

- 1) **Parties.** The parties in this case are Commission Staff and Respondent.
- 2) **Issues.** At the hearing, the Commission will consider whether the Respondent received a prohibited cash contribution from an individual in excess of allowable amounts and failed to report required contributor information on campaign disclosure reports.
- 3) **Procedural history.** Donald Handeland filed a complaint against Kelly Merrick on October 31, 2024. Respondent filed an answer to the complaint on November 21, 2024. Staff’s investigation report recommending the complaint be upheld, in part, and dismissed, in part, was issued on December 19, 2024.

- 4) **Hearing procedures.** The hearing will be conducted as provided in AS 15.13.380, 2 AAC 50.891, and the Alaska Administrative Procedure Act, AS 44.62.330 – 44.62.630. All testimony must be presented or submitted under oath. A party may call witnesses, cross-examine witnesses, present and rebut evidence. If the respondent does not testify, the respondent may be called and examined as if under cross-examination.
- 5) **Evidence and exhibits.** All relevant evidence may be admissible at the hearing. In passing upon the admissibility of evidence, the Commission may consider, but is not bound to follow, the rules of evidence governing general civil proceedings in the courts of the State of Alaska. The Commission may exclude inadmissible evidence and order repetitive evidence discontinued.
- 6) **Prehearing filings.** No later than January 3, 2025, a party:
 - a) may file a list of witnesses expected to testify at the hearing;
 - b) may file copies of exhibits to be presented at the hearing that are marked and identified (for example, Resp.'s Ex. A);
 - c) may file a prehearing memorandum;
 - d) may file prehearing motions, including motions to dismiss, for summary judgment, or to exclude evidence, and
 - e) shall serve all parties and the Complainant with filings submitted.
- 7) **Response to motions and requests for subpoenas.** No later than January 10, 2025, a party
 - a) may respond to a motion; and
 - b) may request the Commission to issue subpoenas to compel the attendance of witnesses, the production of documents, or other things related to the subject of the hearing, and is responsible for serving the subpoena and paying the appropriate witness fee.
- 8) **Extensions of time.** Requests to extend the deadlines in this order must be in writing, filed with the Commission, served on all parties and the Complainant, and supported by good cause.
- 9) **Burden of proof.** The Commission staff has the burden to prove any charges by a preponderance of the evidence.

10) Order of proceedings. Matters considered at a hearing will ordinarily be disposed of in substantially the following order:

- a) pending motions, if any;
- b) complainant may present argument under 2 AAC 50.891(d)
- c) presentation of cases as follows, unless otherwise ordered by the Commission:
 - i) The Commission Staff's direct case, including the investigative report, evidence, and testimony of witnesses;
 - ii) Respondent's direct case;
 - iii) Rebuttal by the Commission Staff; and
 - iv) Closing statements, if any, by Respondent and Commission Staff.

10) Decision and Order. The Commission will issue an order no later than 10 days after the close of the record.

SUMMARY OF COMPLAINT

The Complainant alleges that the Respondent received a prohibited cash contribution from an individual as reported on her 2024 30 Day Primary Campaign Disclosure Report and failed to correctly report contributor information for two individuals on her 2024 7 Day General Campaign Disclosure Report. The Complainant further questioned the validity of multiple individuals providing cash contributions on the same date with identical dollar amounts.¹

SUMMARY OF ANSWERS TO COMPLAINT

The Respondent stated that the reporting irregularities regarding contributor occupation and employer information reporting were the result of donations being received through the payment processor and donation platform Anedot. The Respondent further states that there was no prohibited contribution, and that the cash amount received from a single contributor had been duplicated and reported in error. The Respondent advises that all of these the deficiencies were corrected via amended reporting on October 31, 2024.²

FACTS

Ms. Merrick campaigned for re-election to the State Senate in the 2024 state election. In her 7 Day General Campaign Disclosure Report, filed on October 29, 2024,

she disclosed two contributions over \$50 that did not provide valid occupation and/or employer information for the contributor.³ On her 30 Day Primary Campaign Disclosure Report, filed on July 22, 2024, Ms. Merrick disclosed three cash contributions in the amount of \$69, all of which were received on June 27, 2024. Two of these contributions were shown as being received from Richard Fagg.⁴

LAW AND ANALYSIS

Campaign disclosure statutes mandate that contributions made by an individual must be reported; for all such contributors, the reported information must include the amount and date of the contribution, in addition to the name and address of the contributor. For contributions in excess of \$50 in the aggregate during a calendar year, the principal occupation and the employer of the contributor are also required.⁵ Here, the Respondent reported contributions from two individuals on her 2024 7 Day General Report that lacked accurate occupation and/or employer information. First, there was a \$500 contribution from Darlene Taylor-Bishop made on October 8, 2024, that discloses no principal occupation or employer information. Next, a \$100 contribution from Donna Phillips made on October 20, 2024, that indicates her employer is AaNa but the principal occupation field is populated with what is presumably the contributor's e-mail address. Although Respondent asserts that these irregularities arose from the contributors' failure to correctly complete the applicable fields when submitting their contributions on the Anedot donation platform, and that the entries have been amended⁶, it remains the responsibility of the campaign to correctly report contributions and all requisite details. The failure to do so constitutes a violation of AS 15.13.040(a)(1)(D).

Campaign disclosure statutes prohibit a person or group from making a cash contribution in excess of \$100.⁷ Here, the Respondent reported the receipt of two cash contributions in the amount of \$69 on June 27, 2024, from a single individual (Richard Fagg). Cumulatively, such contributions totaling \$138 would constitute a prohibited contribution; however, the Respondent advised that the single \$69 contribution from this individual had been inadvertently duplicated in the 2024 30 Day Primary Report. The Respondent subsequently corrected the reporting error in an amended report filed on October 31, 2024.⁸ Therefore, as the contribution amount did not exceed the permissible cash contribution limits, there was no violation of AS 15.13.074(e); the failure to correctly and timely report the contribution did, however, constitute a reporting violation.

CONCLUSION

The Respondent violated AS 15.13.040(a)(1)(D) by failing to timely provide required contributor information and to accurately report contribution amounts. There was no violation of AS 15.13.074(e), as the contributor noted in the complaint did not, in actual fact, make a cash contribution in excess of the allowable amount. The other concern noted in the complaint in regard to multiple individuals donating what was perceived as an “odd” amount on the same date does not constitute a violation of AS 15.13.

MAXIMUM CIVIL PENALTIES

The maximum civil penalty for each of the reporting violations, other than a 7 day report, is \$50 per day for each day the violation continues; for a 7 day report, the maximum civil penalty amount is \$500 per day through the date of the election and \$50 per day thereafter.⁹ For purposes of calculating the maximum civil penalties, the accrual of penalties began the day after the report was due (July 22, 2024, in regard to the 30 Day Primary Report and October 30, 2024, in regard to the 7 Day General Report) and was

tolled on October 31, 2024, the date the Complaint was filed. The computed maximum penalty amount for the reporting violation is therefore \$5,050 for the 30 Day report (101 days) and \$500 for the 7 Day report (one day) for a cumulative total maximum penalty of \$5,550.

MITIGATION AND RECOMMENDATION

When staff assesses a penalty, the starting point for calculating the penalty is 2 AAC 50.855. Here, because the Respondent had been a candidate in prior elections and also had a prior late-filed report, staff finds no applicable reductions.¹⁰

A civil penalty may be reduced by a percentage greater than 50% or waived entirely if the penalty is significantly out of proportion to the degree of harm suffered by the public.¹¹ A civil penalty is significantly out of proportion if it exceeds the value of the transactions that were reported late; here, as the penalty amount exceeds of the value of the incorrectly reported information, a reduction is warranted. Moreover, in this instance, as the reporting errors were relatively minor infractions that did not constitute under reporting of contributed amounts or any apparent deliberate attempt to mislead or misinform, the degree of harm suffered by the public is minimal. Staff therefore recommends a 97% reduction of the maximum penalty amount.

This results in a penalty of \$166.50 for the reporting violations. Staff further recommends that the allegation of a prohibited contribution be dismissed.

Background

Section 15.13.040 - Contributions, expenditures, and supplying of services to be reported

On October 29, 2024, Senator Kelly Merrick's campaign filed their 7-day report and reported a \$500 contribution from Darlene Taylor-Bishop. They listed the occupation as "N/A" and employer as "N/A". Alaska Statute 15.13.040 (a) (1) (D) requires that contributions in excess of \$50 in the aggregate during a calendar year, the principal occupation and employer of the contributor be reported. N/A is an abbreviation that can stand for "not applicable," "not available," "not assessed," or "no answer". All are not acceptable under the statute.

Section 15.13.040 - Contributions, expenditures, and supplying of services to be reported

On October 29, 2024, Senator Kelly Merrick's campaign filed their 7 day report and reported a \$100 contribution from Donna Phillips. They listed the occupation as "donnaphill1178@gmail.com". Alaska Statute 15.13.040 (a) (1) (D) requires that contributions in excess of \$50 in the aggregate during a calendar year, the principal occupation and employer of the contributor be reported. An email address is not an occupation.

Section 15.13.074 - Prohibited contributions/ Section 15.13.072 - Restrictions on solicitation and acceptance of contributions

On June 27, 2024, Senator Kelly Merrick's campaign accepted two cash donation from Richard Fagg. Both donations were for \$69 totaling \$138 in cash contributions. This is in violation of Section 15.13.074 (e) "A person or group may not make a cash contribution that exceeds \$100." And Section 15.13.072 (b) " A candidate or an individual who has filed with the commission the document necessary to permit the individual to incur election-related expenses under AS 15.13.100, or a group, may not solicit or accept a cash contribution that exceeds \$100." While the donation of \$69 is humors the second donation is a violation. The fact that both these cash
