This is the status of our FY25 and the actuals for prior years. In FY24, the agency lapsed funds (~\$20,000). The Governor's proposed FY26 budget (attached) shows a slight increase to account for annual personnel increases. The budget will still make its way through the legislature and we should have a final figure by the June meeting.

Personnel: FY25 has nine full-time staff positions. Currently eight are filled. We recently hired a new LOA3, Michelle Melgar who worked for several years as support staff at the AGO. She is quickly getting up to speed and has been a big asset to the team. Recruitment is still underway for our law office assistant 2 position.

Travel: Travel costs from the August meeting are included, as well as the estimated travel costs for the COGEL conference, but it does not include travel for this January meeting.

Contractual: Includes general contractual fees, overhead costs and chargebacks for centralized services provided by the Department of Administration. The current allocation will not cover contractual costs and funds will most likely need to be transferred from the personnel line. In FY24, approximately \$55,000 was transferred from personnel to cover the shortfall. In the event we are fully staffed in FY25 and into FY26, this could be a problem. DOA has been made aware and we are closely monitoring.
