<u>16-04-CD, Alaska Democratic Party/Kay Brown, Executive Director v. Gabrielle</u> LeDoux – Gaby's Tuesday PAC

The complaint filed against Gaby's Tuesday PAC alleges a violation of the Alaska Campaign Disclosure Law, under AS 15.13.072, accepting illegal contributions from a lobbyist that is elligible to vote outside of the candidates district.

The following individuals appeared in person and telephonically and presented their statements and oral arguments on the expedited consideration request.

The complaint will not be heard in an expidited basis. The decision is given to allow parties sufficient time to respond and so that the commission can reconvene with a quorum. While the case is pending, respondent will not accept contributions from lobbyists, will not accept contributions in excess of statutory limits, and will not make contributions to legistlative candidates. If any of that conduct occurs, the complaint will be expedited. A written order will follow.
