Republican Governors Association and Families for Alaska's Future-Dunleavy; and conduct a hearing on a request for expedited consideration of complaint 18-12-CD, Gara v. Families for Alaska's Future-Dunleavy

18-12-CD, Les Gara v. Families for Alaska's Future- Dunleavy

The Complainant, Les Gara, presented argument for the expedited consideration of complaint 18-12-CD.

Stacey Stone, representing Families for Alaska's Future- Dunleavy, provided argument against expedited consideration.

The Commission further clarified that jurisdictional issues are at the Superior Court's discretion.

The Commission also announced its decision to not expedite consideration of Complaint 18-12-CD and remanded the complaint to staff for investigation on a regular basis.
