## Investigation Report Hancock v. Marquardt, 07-02-CD [6]

Telephonic appearance with Tom Amodio representing Mayor Marquardt.

Commissioner Dean disclosed that someone from Mr. Amodio's law firm was representing her in a personal matter. Therefore, she wished to be recused from these deliberations.

Commissioner Hickerson moved to approve the request for a continuance in order for the respondent to have a chance to respond to the staff's report and for staff to be able to respond to the request for dismissal of the complaint.

Commissioner Wood seconded the motion.

The motion passed 3 to 0 in favor.

#### **Continuation of Discussion Concerning Public Comment Request**

Ms. DeYoung, Assistant Attorney General reported back to the Commission that the statute was fairly clear in that the Commission did not have the ability to grant extensions for report due dates.

Commissioner Hickerson moved to direct staff to present these matters to the Commission for adjudication and recommend waiving the penalty due to personal or family emergency. The staff was directed to work with the legislature on addressing this matter.

Commissioner Wood seconded the motion.

The motion passed 4 to 0 in favor.

## Lobbying Compliance & Ethics Training Update [\*]

Ms. Ware presented an update of the training that was given to lobbyists and employers of lobbyists.

Commissioner Hickerson moved to adopt a regulation of the lobbying manual by reference and a regulation of a code of ethics for lobbyists and their employers.

The motion was seconded by Commissioner Wood.

## The motion passed 4 to 0 in favor.

Ms. Ware requested that the Commission consider waiving civil penalties for reports that are filed late due to the conversion to the new on line filing system. The Commission took no action on this request.

## Follow-up on Metcalfe v. Mcguire, 07-01-LFD

Telephonic appearance from Charles Dunnagan, attorney for Senator Lesil McGuire.

Ms. DeYoung presented a report concerning her review of this matter for referral to the Select Ethics Committee for them to take action. Ms. DeYoung reported that she found no illegal conduct had taken place with respect to lobbying or legislative ethics.

Commissioner Hickerson moved to have the Commission refer the matter of the McGuire Providence contract to the Legislative Ethics Committee to determine whether any action should be taken.

## Commissioner Dean seconded the motion.

The motion passed 3 to 1 in favor.

## Appeal of staff dismissal in Metcalfe v. McGuire, 07-03-LFD

Telephonic appearance from Charles Dunnagan, attorney for Senator Lesil McGuire.

Ms. Miles presented Mr. Metcalfe's appeal to the Commission for its consideration.

Commissioner Wood moved to sustain the decision of the Commission regarding this matter.
