### Advisory Opinion Request, AO 10-36-CD, Prosperity Alaska [6]

Staff presented the additional information requested by the Commission from the November 18<sup>th</sup> Commission meeting and staff's proposed response to the advisory opinion request.

Commissioner King made a motion to accept staff recommendation. Commissioner Ballenger seconded the motion.

During the discussion, the Commissioners rejected the staff's proposed response to the advisory opinion request by Prosperity Alaska, because there was not sufficient information to make a determination. The Commission could not determine whether Prosperity Alaska is or is not a group at this time.

The Commission voted 0-5. Motion failed. Advisory Opinion 10-36-CD Prosperity Alaska was not approved.

Chair Hickerson announced the Commission will deliberate several matters and will not be back on the public record.
