#### **Other Relevant Dates for the 2020 State Primary Election:**

**Friday, July 17, 2020** (33 days prior to the date of the Primary Election)

The last day a candidate may give or loan their campaign more than \$5000.

**Friday, October 2, 2020**, (45 days after the date of the Primary Election)

The last day a candidate may accept contributions.

**Monday, February 1, 2021**

The date by which candidates must distribute the amount held in their campaign account.

### **Tuesday, November 3, 2020 General Election**

<b>Final Report</b>	October 25 – February 1, 2021	<b>Tuesday, February 16, 2021</b>

#### **Other Relevant Dates for the 2020 State General Election:**

**Friday, October 2, 2020** (33 days prior to the date of the General Election)

The last day a candidate may give or loan their campaign more than \$5000.

**Friday, December 18, 2020** (45 days after the date of the General Election)

The last day a candidate may accept contributions.

**Monday, February 1, 2021**

The date by which candidates must distribute the amount held in their campaign account.

\*During the 9 days before an election, you must report the contributor name and amount of all monetary and non-monetary contributions over \$250 to APOC within 24 hours of the time you receive each contribution.

You may need to report each day during that period, or not at all.
