All State of Alaska governmental entities may purchase from this contract. Other State of Alaska Governmental entities may include the Alaska Legislative Branch, the Alaska Court System, the University of Alaska, Boards and Commissions, and all State of Alaska political subdivisions i.e. cities, boroughs, and school districts.

Agencies shall contact the top ranked bidder first. If they are unable to provide the service, the agency shall move on to the next ranked Contractor and so on until they are able to secure moving services.
