



SMALL PACKAGE DELIVERY SERVICES

The Western States Contracting Alliance (WSCA) leverages the buying power of 15 western states to offer exceptional pricing for participating states and their political subdivisions. Alaska is an active member of WSCA. In order to use a WSCA contract, the state must sign a Participating Addendum (PA).

WSCA has the following non-mandatory contract for small package delivery services:
