| Plate transfer - \$5.00         | Provide plate number that is being transferred and a copy of the last registration, if available. The name on the previous registration and new registration must match. <b>(Registration)</b>                                   |
| Special plate type - various    | Provide required documents for request. (ie Vet plates - DD214) There is a separate application (803) to order personalized plates. <b>(Registration, month &amp; year tabs provided with new plates)</b>                        |
| Duplicate registration - \$2.00 | <b>(Registration)</b>  |
| Duplicate title - \$15.00       | Must provide a notarized lost title affidavit (809) in addition to this application. <b>(Title &amp; registration)</b>   |
| Lost plate/tab - \$5.00         | New registration is issued with either of these. The correct month and year tabs are included in the \$5.00 fee for duplicate license plates.  |
