Subject: Adult Probation Officer Study

## Summary:

The Division of Personnel & Labor Relations (DOP&LR) Classification Section has completed the Adult Probation Officer study. This study was initiated by the Department of Corrections (DOC) to address changes in the work of Adult Probation Officers as a result of the passage of Senate Bill 91 by the Alaska State Legislature in 2016, and the subsequent creation and merging of the Pretrial Enforcement Division into the former Division of Probation and Parole to form the Division of Pretrial, Probation and Parole (DP3).

Job analysis supported the establishment of three class series to address the changes in probation and parole work in the State of Alaska. Adult Probation Officers perform a broad range of probation/parole functions and provide rehabilitative services for an adult offender population in an institutional or community setting. Pretrial Services Officers supervise and enforce court-ordered conditions of release for unsentenced defendants awaiting trial in a community setting. Pretrial, Probation and Parole Administrators manage probation, parole, and/or pretrial functions and oversee community-based services and operations.

Classification determined that it is appropriate to create three distinct class series. The Adult Probation Officer 1-3 series retains the existing trainee, journey, and supervisory levels, but differentiates institutional and field probation/parole work into two separate classes. The Pretrial Services Officer 1-3 series is established to address the pretrial enforcement program established under AS 33.07.010. The

Pretrial, Probation and Parole Administrator 1-3 is essentially a retitling of the existing Adult Probation Officer 4-6 classes to address the managerial aspects of the probation, parole, and pretrial functions.

The final job and salary analysis are as follows:
