

Notice of Personnel Board Meeting

The Personnel Board for the State of Alaska will hold a meeting on November 3, 2008, starting at 12:00 p.m., in Room 880, Frontier Building, 3601 C Street, Anchorage, Alaska, pursuant to authority vested in it under AS 39.25.070 on the following matters:

To take action on minutes from earlier meetings, to review outstanding ethics cases and reports, to consider the adoption of proposed amendments to Personnel and Leave Rules, and other matters that may come before the board within the scope of this notice. Deliberations on ethics matters will occur in executive session because these matters are required to be confidential under AS 39.52.340.

The proposed amendments clarify the compensation authorized for a deputy head of a principal executive department, nepotism, and implement recently passed legislation (HB 252), chapter 80, SLA 2008 which provides leave for organ and bone marrow donations.

- 2 AAC 07.950. Nepotism
- 2 AAC 07.316. Salary for deputy heads of a principal department.

notice, or decide to take no action on them. The language of the final regulations may vary from that of the proposed regulations. You should comment during the time allowed if your interests could be affected.


