**LOA Extensions**



These Letters of Agreement will be extended to April 30, 2010 or until a new collective bargaining agreement is ratified by LTC members, whichever occurs first. This MOU may be cancelled by either party with fifteen calendar days notice to the other party. The following Letters of Agreement apply to this MOU:


