
LOA Extension

It is agreed between the parties that the following Letters of Agreement are extended past the expiration date of the current collective bargaining agreement, June 30, 2009. These Letters of Agreement will be extended to December 31, 2009 or until a new collective bargaining agreement is ratified by LTC members, whichever occurs first (unless an earlier expiration date is noted in parentheses).
