Reminder: State-Sponsored Health Plan has Advantages for Poli-Sub Employers

If you are a PERS employer in a municipality, school district or other political subdivision of the state it may be to your advantage to take a look at the state-sponsored Political Subdivision Group Health and Life Insurance Plan. The plan has some built-in features that help reduce costs to employers and employees.

Articles in the [November](#) and [December](#) 2007 issues of the Employers' Edge included details on the state-sponsored health plan and the options available to employers.

The [Alaska Municipal League-Joint Insurance Association](#) (AML-JIA) markets this insurance plan and Aetna is the carrier.

Removing Terminated Employees from Access to Member Services

If you have an employee who terminates who had access to Member Services, you must submit a form that will prevent the former employee from having continuing access to Member Services.

Political Subdivision employers should submit this [LogonID Request form](#). **State of Alaska** employers should submit this [form](#).

For both forms, there is an "ACTION" option near the top that says "DELETE - Removes all authority for this user."
