The 24th Alaska Legislature passed Senate Bill 141 (SB141) containing comprehensive retirement system changes. Effective July 1, 2010, SB 141 repeals the provision that allows members to reinstate service by repaying their refunded Public Employees Retirement System (PERS) contributions (Alaska Statute 39.35.350).

Our records indicate you are a former member and that you refunded your PERS account. In order for you to reinstate this PERS service and your former tier status, Tier I, you must reemploy in an Alaska PERS eligible position not later than June 30, 2010. If you do not reemploy in an eligible position on or before June 30, 2010, Alaska Statute prohibits you from reinstating this service, and you will not be able to reestablish Tier I benefit status.
