## Fund Benchmark<sup>1</sup>

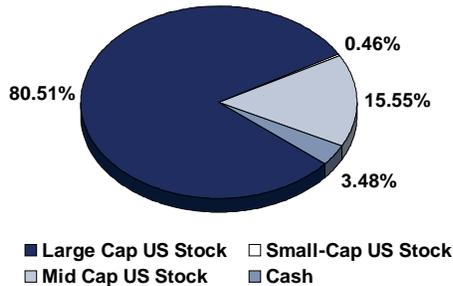

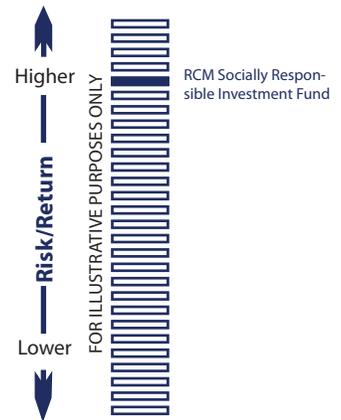
