Investment Objective

To provide a high level of current income consistent with preserving principal and liquidity, and the maintenance of a stable \$1.00 per share net asset value ("NAV"). The Fund invests in U.S. Treasury securities with maturities of 397 calendar days or less.

How The Fund Works

The Fund is a money market fund that seeks to achieve its investment objective by investing substantially all of its investable assets in the State Street Money Market Portfolio of State Street Master Funds, which has the same investment objective as, and investment policies that are substantially similar to those of, the Fund. The Fund attempts to achieve its investment objective by investing exclusively in direct obligations of the U.S. Treasury, such as U.S. Treasury bills, notes, and bonds. The Fund may also invest in other mutual funds, subject to regulatory limitations, that invest exclusively in such obligations.

Investor Profile

Cash equivalent investments may be most appropriate for someone wanting to safeguard principal value or balance a portfolio with more aggressive investments. The Fund may be appropriate for the investor who may be nearing retirement or may require stability and asset liquidity.

Fund Benchmark

The iMoneyNet Treasury Institutional Average includes only institutional government funds that invest solely in obligations of the U.S. Treasury.

Fund Management

State Street Global Advisors manages the Fund. State Street Bank and Trust Company, a wholly-owned subsidiary of State Street Boston Corporation, is

one of the nation's largest managers of institutional assets with over \$1,900 billion in assets under management. State Street Global Advisors (SSgA), the institutional investment management area of State Street, was established in 1978. Since then, their focus has been on providing comprehensive, highly disciplined, risk-controlled investment strategies to the global marketplace.

State Street Global Advisors is a bank as defined by the Investment Advisers Act of 1940 and is therefore exempt from registration under the Act.
