Alaska is an active member of NASPO. In order to use a NASPO contract, the state must sign a Participating Addendum (PA).

Both contracts include a full line catalog of laboratory equipment and supplies. There is a \$75,000 (per item) ceiling within each order. Separate items that cost more than \$75,000 after the NASPO discount has been applied.
