On behalf of the member states of ValuePoint, this contract offers nationwide and international car rental services, including but not limited to online booking through a Travel Management Contractor, internet-based booking, and agent assisted services, related fulfillment services.

The purpose of this contract is to have nationwide car rental services providers with the ability to provide domestic (North America) and international car rental services for public employees, and other authorized users on official business within state departments, institutions, agencies, and political subdivisions and other eligible entities (i.e. colleges, school districts, counties, cities, some nonprofit organizations, etc.) for all states, the District of Columbia, and territories of the United States.

**Contract Term:** May 21, 2019 to May 20, 2025.
