**Contract Term:** April 1, 2021 – March 31, 2026

**Renewal Options:** None remaining

The Environmental Systems Research Institute (Esri) publishes proprietary geographic information systems (GIS) software and services. This contract award is intended to provide a direct means for State of Alaska executive branch, legislative branch, and court system agencies, along with qualifying political subdivisions to purchase the following Esri products and services:

- 1) **Esri Branded Enterprise Software:** The software available from this contract is listed in the attached price list. Executive branch agencies must complete a Brand Specific Determination as described below.
- 2) **Software Maintenance:** All software maintenance available from Esri may be purchased from this contract.
- 3) **ESRI Training:** Esri offers a wide range of training courses that can be presented locally or at the Esri Learning Center in Redlands, California. Course titles are included in the attached price list or at: <http://www.esri.com/training/main>

The terms & conditions for training are located in Article 6 of the attached Master Purchase Agreement.

- 4) **Esri Enterprise Advantage Program (EAP):** The EAP is a subscription service for preferred high volume customers and provides services such as an assigned technical advisor, annual planning and review, a collaborative technical work plan, quarterly technology, and flexible access to assistance for training, premium support, and consulting support:

The EAP is not a solution for individual projects but rather a tool to provide assistance for an agency that needs more of a master plan for engaging Esri. Contact Esri for more information regarding the EAP.

**Instructions for using the Esri/Alaska Master Purchase Agreement:**

**Purchase Order Requirements:** The following information must be included in each Purchase Order or Delivery Order.

- Name or identification of Licensee, place of delivery and the end user name and contact information
- Purchase order number
- Date delivery is requested (minimum thirty [30] days after Esri receipt of order)
- Primary site for maintenance if primary maintenance is not ordered
- Quantity, description, and unit price
- On the face of the purchase, order print the following statement: "Subject to and governed by Esri MPA No. 2015MPA1955/Alaska Agreement No. 2015-9900-3033."

**Acknowledgment Statement:** All agencies must include a signed copy of the attached *Acknowledgment Statement* with their purchase/delivery order. The *Acknowledgment Statement* is confirmation that the agency agrees to and will abide with the master agreement terms & conditions.

**Brand Specific Determination:** For each purchase through the contract, executive branch agencies are required to include a brand specific determination in the procurement file, based on valid reasons that explain why only the Esri products or services will meet the agency's needs. Examples of a valid determination may include: a substantial installed product base, unique technology requirements, or specific departmental requirements that cannot be met by competing products.
